Hindi Image Editor is a fast and fun way to share experiences with your friends and the world around you. You can edit or create and share images to your friends. Hindi Image Editor provides share your creations to users around the world. We talk about what information we collect and how this affects you.

When you use these services in the Hindi Image Editor you'll share some information with us.

We get that that can affect your privacy. So we want to be upfront about the information we collect, how we use it, whom we share it with, and the choices we give you to control, access, and update your information.

That's why we've written this Privacy Policy. And it's why we've tried to write it in a way that's blissfully free of the legalese that often clouds these documents. Of course, if you still have questions about anything in our Privacy Policy, just contact us.

When we say "Hindi Image Editor," "our," "we," or "us," we're talking about Hindi Image Editor Inc. This Privacy Policy ("Privacy Policy") applies to all of our apps, services, features, software, and website (together, "Services") unless specified otherwise.

Information We Collect is the Information you choose to give us.

Here's a little more detail on each of this category

When you interact with our services, we collect the information that you choose to share with us. For example, most of the users remove logo to use Hindi Image Editor, so we need to collect a few important details about you, such as: a unique device id.

Of course, you'll also provide us whatever information you send through the services, such as edited images shared publicly to your friends. Keep in mind that the users you send images and any other content to can always save that content or copy it outside the app.

So, the same common sense that applies to the Internet at large applies to Hindi Image Editor as well: Don't send messages or share content that you wouldn't want someone to save or share.

It probably goes without saying, but we'll say it anyway: When you contact Hindi Image Editor Support or communicate with us in any other way, we'll collect whatever information you volunteer.

The services may also contain third-party links and search results, include third-party integrations, or offer a co-branded or third-party-branded service. By going to those links, using the third-party integration, or using a co-branded or third-party-branded service, you may be providing information (including personal information) directly to the third party, us, or both.

You acknowledge and agree that we are not responsible for how those third parties collect or use your information. As always, we encourage you to review the privacy policies of every third-party website or service that you visit or use; including those third parties you interact with through our services.

#### **How Long We Keep Your Content**

Hindi Image Editor lets you share images and text. On our end, that means that we automatically delete the work content (image and text send your friends) from our servers at any time.

But remember: There are various ways Hindi Image Editor can save your content and also upload it to Hindi Image Editor.

We go into more detail below about how users can save Hindi Image Editor Content.

Finally—and this is important—you should understand that users who see the content you provide can always save it using any number of techniques: screenshots, in-app functionality, or any other image-capture technology. It's also possible, as with any digital information, that someone might be able to access messages forensically or find them in a device's temporary storage.

Keep in mind that, while our systems are designed to carry out our deletion practices automatically, we cannot promise that deletion will occur within a specific timeframe. And we may need to suspend those deletion practices if we receive valid legal process asking us to preserve content or if we receive reports of abuse or other Terms of Service violations.

Finally, we may also retain certain information in backup for a limited period of time or as required by law.

#### Log Data

I want to inform you that whenever you use my Service, in a case of an error in the app I collect data and information (through third party products) on your phone called Log Data. This Log Data may include information such as your device Internet Protocol ("IP") address, device name, operating system version, the configuration of the app when utilizing my Service, the time and date of your use of the Service, and other statistics.

## **Survey Serving Technology**

This app uses Pollfish SDK. Pollfish is an on-line survey platform, through which, anyone may conduct surveys. Pollfish collaborates with Developers of applications for smartphones in order to have access to users of such applications and address survey questionnaires to them. When a user connects to this app, a specific set of user's device data (including Advertising ID which will may be processed by Pollfish only in strict compliance with google play policies- and/or other device data) and response meta-data (including information about the apps which the user has installed in his mobile phone) is automatically sent to Pollfish servers, in order for Pollfish to discern whether the user is eligible for a survey. These data will be associated with your answers to the questionnaires whenever Pollfish sents such questionnaires to eligible users. Furthermore, you are informed that you may disable Pollfish operation at any time by using the Pollfish "opt out section" available on Pollfish website.
